Further to discussions, both parties undertake to sign this Letter of Understanding (hereinafter referred to as the "Agreement") for conducting Pathology and Microbiology tests at centers operated by first party, on rates mutually agreed by both parties. Om Laboratory and Anantrao Kanase Homeopathic Medical College and Hospital have agreed on the following broad terms and conditions of this engagement as under:-

1. Appropriate collection and storage of samples, along with dully filled requisition forms will be the responsibility of Anantrao Kanase Homeopathic Medical College and Hospital.
2. Samples will be collected by Om Laboratory at the timings decided and mutually agreed upon by both parties from the premises of Anantrao Kanase Homeopathic Medical College and Hospital.
3. Om Laboratory is responsible for timely reporting of samples and for informing about delay in the same in case of uncontrolled circumstances.
4. Billing will be done on monthly basis as per the rates discussed and agreed upon by the both the parties. A credit period of 20 days will be provided for the payment of previous month's bill. The payments will be settled by Anantrao Kanase Homeopathic Medical College and Hospital by way of cheque /DD in the name of Om Laboratory or alternatively the same shall be credited to the specified bank account of Om Laboratory within the above time limit:
5. The rates will be revised once a year mostly in April with one month prior notice.
6. This Agreement will be for a term of 1(one) year commencing from the date of this Agreement. Either party may cancel or terminate this Agreement before the expiry date mentioned above, by giving 1(one) month's advance notice in writing to this effect to the other party. The agreement is terminated only and only after full payment is done by Anantrao Kanase Homeopathic Medical College and Hospital to Om Laboratory.

7. All notices, demands or other communications to be given or delivered under or by reason of the provisions of this Agreement will be in writing and delivered to the other Party at their addresses mentioned herein.
8. Om Laboratory shall maintain strict confidentiality while handling the report of each of the samples of Anantrao Kanase Homeopathic Medical College and Hospital and shall not disclose the same to any third part ,the test images and reports of Om Laboratory are its intellectual property rights and Om Laboratory has the absolute right to hold and preserve the same with it.
9. Either Party will indemnify the other party against acts arising by reason of any negligence, misconduct, or breach of any obligation hereunder by and on their part in relation to its performance of this agreement.
10. Arbitration shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996. The place of arbitration shall be Pune.
11. either party is prevented from performing its obligation under this MOU from causes which are beyond its reasonable control, such as strikes, labor controversies, fires, Acts of God or, embargoes, governmental orders or restrictions or, the Party is excused from non-performance of its obligation during the period while such cause continues to exist. Provided that any Party who is, by reason of Force Majeure, unable to perform any obligation or condition required by this MOU to be performed shall notify the other Party as soon as possible in writing, however, this shall extend only upto a period of 30(thirty) days, after which either party shall be entitled to terminate this agreement.
12. This Agreement together with any Appendices/Annexure/Schedules attached here to constitutes the entire Agreement between the parties and supersedes, with respect to the matters regulated herein, and all other mutual understandings, accord and agreements, irrespective of their form between


