

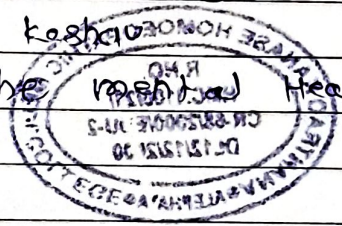

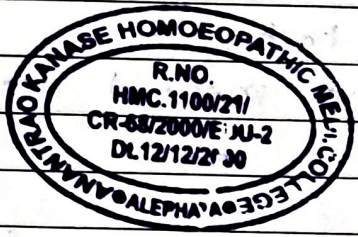

 उपरोक्त संदर्भीय विषयांस अनुसरून आपणांस कळविण्यात येते की, विद्यापीठाच्या बी. एच. एम. एस. अभ्यासक्रमाच्या हिवाळी सत्र २०२३ परीक्षेचे परीक्षा अर्ज महाविद्यालयामार्फत विद्यापीठास प्राप्त होत आहेत. सदर अर्जाची विद्यापीठ स्तरावर छाननी करतांना, काही महाविद्यालयामार्फत विषयनिहाय कमी उपस्थिती असणाऱ्या विद्यार्थ्यांचे सुद्धा परीक्षा अर्ज विद्यापीठात सादर केले जातात. परंतु लेखी व प्रात्यक्षिक परीक्षेकरीता अनुक्रमे किमान ७५% व किमान ८०% उपस्थिती असणे अनिवार्य आहे.

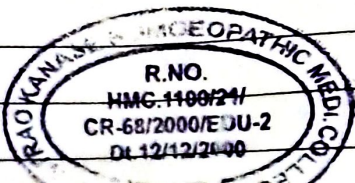
subject - regarding eligibility of students appearing for MUHS exams (winter exams 2023)



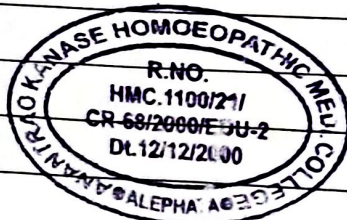

→ The punishment of appearing for all subjects was declared & this was to be discussed

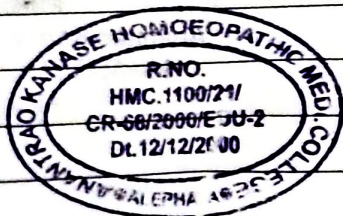
→ Care to be taken & checking to be done strictly & no such incidence occurs in future was discussed.

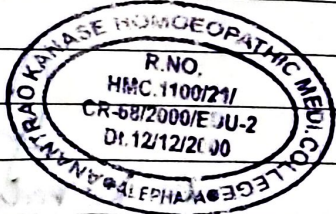
